## **Evaluation of the NONFORLESL Project**

### Major work components of the External Evaluator

The major tasks of the external evaluator will be materialised in two reports, mid term (December 2015) and final report (October/November 2016). They will be related to the monitoring and evaluation of the project intellectual outputs:

O1 Comparative Study Analysis Report: Preventing Early School Leaving through the recognition and validation of non-formal and informal learning, within formal education - from theory to school practice (participants' views)

**The monitoring and evaluation** of **the Output** O1 will be a continuous process and will be done internally by the partner responsible for its implementation and at **the final stage by the external evaluators**. The detailed report produced reflecting the current state of each participating country, the number of questionnaires completed by the interest groups and the analysis of their views and needs necessary of the design of the OER tool are indications of the quality of the project's progress.

# O2 Framework for the recognition and validation of Non-formal learning within students' assessment procedure in schools

**The monitoring and evaluation of the Output O2** will be a continuous process and will be done internally by the partner responsible for its implementation and **at the final stage by the external evaluator**. The framework to be produced, the award system to be specified, the allocation of learning into certain types of skills and competences and the strategy to be followed for its implementation in schools are indications of the quality of the project progress.

O3 Analysis, design and development of the NON-FOR-LESL Open Education Resource (OER) tool/ method

**The monitoring and the evaluation of the Output O3** will be reviewed internally by the leading organisation, and **at the end of the project by the external evaluator**.

O4 Design and production of the "NON-FOR-LESL INFORMATION PACK": Step-by-step guide (manual) for the implementation and Training course for teachers/students

The monitoring and the evaluation of the Output O4 and activities will be reviewed internally by the Leading Organisation, and at the end of the project by the external evaluator. Most importantly the monitoring and evaluation of the activities will be assessed by the feedback given by the users (teachers and students) in Output 6. The students' involvement, response, motivation and improvement in relation to their self-esteem, as well as the teachers' comments on the product will offer valuable feedback. The Participants' Committee will also be asked to internally evaluate this Output.

### O5 Case-study and portfolio evaluation report for the Implementation of NONFORLESL tool

**The monitoring and the evaluation of the deliverables of the Output O5** will be reviewed internally by the Activity Leader who will be responsible to produce guidelines and procedures for the recording of the observation and on-going evaluation of the implementation, and **at the end of the project by the external evaluator.** Most importantly the monitoring and evaluation of the activities will be assessed by the feedback given by all participants, their involvement, response, satisfaction and improvement on the set course and activities planned. The Participants' Committee will also be asked to internally evaluate this Work Package

O6 Production of an Implementation Strategy for the NONFORLESL OER tool/method as part of the overall evaluation of the project

*The monitoring and the evaluation of the Output O6 will be done externally by the External Evaluator and internally by the Management Committee (M.C.).* 

#### **Multiplier events**

**The monitoring and evaluation of the Multiplier Event** will be a continuous process and will be done internally by the partner responsible for its implementation and **at the final stage by the external evaluators.** The participation of students and teachers in the activities organized at the school level, the completed questionnaires for the collection of their views and opinions are indications of the quality of the project's progress.

The Evaluator will provide objective assessment of the project implementation. The External Evaluator will work with the Project Manager, Participants' and Management Committees, to collect, analyze, and disseminate data. The Evaluator will maintain ongoing communication with the Project Manager and partners to ensure timely implementation of project objectives and progress toward project outcomes.
